I desire said land mentioned in section 3 of this will divided as follows: To my son John A. Redman the one fifth (1/5) part, To my son Tom M. Redman the one fifth (1/5) part, To my son L. T. Redman the one fifth (1/5) part, to my daughter Julia E. Redman the one fifth part, to my daughter Minerva F. Redman the two fifteenth (2/15) part, to my grandson Edgar M. Ellis, son of my daughter Mary A. Ellis, dec'd the one fifteenth (1/15) part.

I desire that all my personal property be used first to the payment of my debts and that all the residue after paying said debts be distributed equally among all my heirs above mentioned.
